Hello everyone!

The doors are open and the classrooms are full of students. During my school visits when I walk through classrooms I see students engaged in discussion and working together. I see teachers facilitating activities and students creating and learning. I see excitement from both our students and our staff members. I see classroom routines being established and expectations are being discussed. I have observed so many positives and I am excited to see such a great start to the year in each of our schools.



The start of school is a transition time for families so I thought that it may be helpful to share some tips to help establish a new routine for your family. Here are some ideas that may benefit your children as they adjust to the start of the school year.

- 1. Get your child to bed on time and establish a bedtime routine. How much sleep does your child need? The research out there varies a bit on this one but most researchers will land between 8-11 hours of sleep a night. It is important to establish a consistent bedtime for your child. This will make it easier for them to wake up in the morning. If you have teenagers my suggestion is to keep all technology out of their room.
- **2. Make a comfortable study area at home.** When students come home from school make homework a priority. Have your child get a snack and then get started. Find a place in your home with minimal distractions yet close enough to monitor progress. One important part to this is working with your child on prioritizing homework to be done first. After they finish, scan the work to make sure they have completed it to the best of their abilities. Take some time to help your child be organized. This is something they can learn to be good at but they will need coaching from you.
- **3. Take charge of TV and technology time.** Set parameters around the use of technology in your home. Technology is fantastic and often used to complete homework, however too much time spent on a phone, computer, or watching TV takes away from the personal interactions and exercise that children need as a part of a healthy lifestyle.
- **4. Read with your child daily.** For younger children take the time to read to them or even better listen as they read to you. The best time is when they are in bed just before they go to sleep. It is a great way for them to wind down from all the activity of the day. Follow the reading up with a short talk about today's events and tomorrow's plans. Older children don't like to read with parents as much as younger children but give them reading time and go in and ask them about what they are reading. Ask questions and then ask about today's events and tomorrow's plans. Both the reading and the conversation will go a long way academically and emotionally.

Each of these areas is important to the development of your child, however every family dynamic is different. For example, if you have a big family have the older children read to the younger children. Or if you work late make breakfast be the time for a conversation. It may not go perfectly every night but your efforts will not go unnoticed by your child and in the long run it will benefit them tremendously.



#### Officials Responsible for Records

The Superintendent is administratively responsible for assuring the confidentiality of personally identifiable student information on a district-wide basis. The principal of each school within the District is administratively responsible at the building level for the management of student records in a confidential manner and in accordance with District policy and procedures. The following is a listing of the titles and office address of these individuals: **Superintendent Brian Jaeger** 711 South Maple; **High School Principal Joan Young** 850 East Oak; **Middle School Principal Brent Meier**, 217 South Maple; **Elementary Principal Denny Folken**, 321 West South Street.

#### **Inspection of Instructional Materials**

Parents and other members of the school district community may review instructional materials used by the student. Arrangements to review materials must be made through the appropriate building level administrator.

#### **Parent/Student Rights**

The Monticello Community School District maintains confidential records for all students currently or previously enrolled as is consistent with the District's responsibility for the provision of educational programs and services and the requirements of state/federal law and regulation. Copies of the District's student records policy are available upon request to the office of the superintendent or the principal of any district school.

#### **Asbestos Notification**

The Asbestos Hazard Emergency Response Act of 1986 (referred to as AHERA) was enacted by Congress to determine the extent of and develop solutions for any problems schools may have with asbestos. This notification, education and training of our employees, plans and procedures to minimize the disturbance of asbestos containing materials, and plans for regular surveillance of the asbestos containing materials are a part of our efforts to meet government regulations. A copy of the asbestos management plan is available for your inspection in our administrative offices during regular office hours.

#### **Use of Video Cameras on School Buses**

The Monticello Community School District Board of Directors has authorized the use of video cameras on school district transportation. The video cameras will be used to monitor student behavior to maintain order on school transportation to promote and maintain a safe environment. Students and parents are hereby notified that the content of video recordings may be used in a student disciplinary proceeding. The content of video recordings may be confidential student records and, if so, will be retained with other student records. Video recordings will only be retained if necessary for use in a student disciplinary proceeding or other matter as determined necessary by the administration. Parents may request to view video recordings of their child if the video recordings are used in a disciplinary proceeding involving their child.

#### **Open Enrollment Timelines**

Parents/quardians considering the use of the open enrollment option to enroll their child/ren in a public school district in the State of Iowa other than their district of residence should be aware of the following: An application to is to be filed with the resident district by March 1 to be considered for the following year. Those enrolling in kindergarten have until September 1 to file an application for open enrollment. In order to qualify for open enrollment after the March 1st deadline, the student must meet the "good cause" definition. Good cause relates to: (1) There is a change in district of residence due to: family move, change in marital status, foster care, adoption, or treatment program; (2) Participation in foreign exchange program; (3) Failure of negotiations for reorganization or whole grade sharing; (4) Loss of accreditation or revocation of a private charter school; (5) Pervasive harassment or severe health (determined by the district). If these circumstances occur after March 1, a parent or quardian may file a "late" open enrollment application. Transportation to and from a point on a regular school bus route of the receiving district is the responsibility of the parent/quardian, unless economic eligibility requirements are met and the receiving district is next to the resident district. Parents/quardians of open enrolled students whose income falls below 160% of the federal poverty guidelines are eligible for transportation assistance. This may be in the form of actual transportation or in the form of a cash stipend. Parents should be aware that open enrollment may result in the loss of athletic eligibility. Students who open enroll in grades 9-12 must wait 90 days to participate in interscholastic contests at the varsity level. Children will remain on open enrollment status unless the parent/guardian decides to cancel it or the agreement is terminated as a result of the parent/guardian moving, by not sending the child to the requested district or any other circumstance that results in the pupil no longer attending the receiving district. #### **Annual Notices**, (continued)

#### **Notice Regarding Protection of Student Rights**

The Protection of Pupil Rights Amendment (PPRA) affords parents and students over eighteen (18) years of age and/or students who are considered emancipated minors pursuant to lowa laws ("eligible students") certain rights with respect to the district's conduct of surveys, collection and use of information for marketing purposes and certain physical exams. These include the following rights:

The right to consent before a student is required to submit to a survey that concerns one or more of the following protected areas ("protected information surveys") if the survey is funded in whole or in part by a program of the U.S. Department of Education (ED):

Political affiliations or beliefs of the student or the student's parents;

Mental or psychological problems of the student or the student's family;

Sex behaviors or attitudes;

Illegal, anti-social, self-incriminating or demeaning behavior;

Critical appraisals of others with whom the respondents have close family relationships;

Legally recognized privileged relationships, such as with lawyers, doctors, or ministers;

Religious practices, affiliations, or beliefs of the students or parents; or

Income, other than as required by law to determine program eligibility.

The right to receive notice and an opportunity to opt a student out of a protected information survey, which concerns any of the protected areas outlined above, regardless of the source of funding of the survey.

The right to receive notice and an opportunity to opt a student out of any non-emergency, invasive physical examination or screening required as a condition of attendance, administered by the school or its agent, and not necessary to protect the immediate health and safety of a student, except for hearing, vision, or scoliosis screenings, or any physical examination or screening permitted or required under lowa law.

The right to receive notice and an opportunity to opt a student out of activities involving the collection, disclosure, or use of personal information obtained from students for marketing or to sell or otherwise distribute the information to others.

The right to inspect, upon request and before administration or use, any of the following information:

Protected information surveys of students;

Instruments used to collect personal information from students for any of the above marketing, sales, or other distribution purposes; and Instructional materials used as part of the educational curriculum.

The right to file a complaint with the U.S. Department of Education concerning alleged failures by the district to comply with the requirements of PPRA. The name and address of the office that administers PPRA is: Family Policy Compliance Office, U.S. Department of Education, 400 Maryland Ave., SW, Washington, DC, 20202-5920.

The district will also directly notify, such as through U.S. Mail or e-mail, parents of students who are scheduled to participate in the specific activities and will provide an opportunity for the parent to consent to or opt his/her child out of participation of the specific activity or survey. The district will provide the Schedule of Activities outlining the activities to which this notice applies, preferably at the same time as the district provides this notice, if the district has identified the specific or approximate dates of the activities and surveys at that time. For surveys and activities scheduled after the school year starts, parents will be provided reasonable notification of the planned activities and surveys listed below and/or planned activities and surveys that may arise during the school year that are not listed below, and will be provided an opportunity to consent to or opt his/her child out of participation of the specific activity or survey. Parents will also be provided an opportunity to review any pertinent surveys.

The district will develop policies, in consultation with parents, regarding these rights, as well as arrangements to protect student privacy in the administration of protected information surveys and the collection, disclosure, or use of personal information for marketing, sales or other distribution purposes. The district will directly notify parents of these policies at least annually at the start of the school year and after any substantive changes.

#### Notification of Rights under FERPA for Elementary and Secondary Schools

The Family Educational Rights and Privacy Act (FERPA) affords parents and students who are 18 years of age or older ("eligible students") certain rights with respect to the student's education records. These rights are:

- 1. The right to inspect and review the student's education records within 45 days after the day the School receives a request for access. Parents or eligible students should submit to the school principal, or appropriate school official, a written request that identifies the record(s) they wish to inspect. The school official will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected.
- 2. The right to request the amendment of the student's education records that the parent or eligible student believes are inaccurate, misleading, or otherwise in violation of the student's privacy rights under FERPA.
  - Parents or eligible students who wish to ask the School to amend a record should write the school principal, or appropriate school official, clearly identify the part of the record they want changed, and specify why it should be changed. If the School decides not to amend the record as requested by the parent or eligible student, the School will notify the parent or eligible student of the decision and advise them of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when notified of the right to a hearing.
- 3. The right to privacy of personally identifiable information in the student's education records, except to the extent that FERPA authorizes disclosure without consent.
  - One exception, which permits disclosure without consent, is disclosure to school officials with legitimate educational interests. A school official is a person employed by the school as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel) or a person serving on the school board; a person or company with whom the school has outsourced services or functions it would otherwise use its own employees to perform (such as an attorney, auditor, medical consultant, or therapist); a parent or student serving on an official committee, such as a disciplinary or grievance committee; or a parent, student, or other volunteer assisting another school official in performing his or her tasks.
- 4. A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility.

The right to file a complaint with the U.S. Department of Education concerning alleged failures by the School to comply with the requirements of FERPA. The name and address of the office that administers FERPA:
