

Jones County Preschool Scholarship Program Information & Application 2015-2016

Thank you for your interest in the Jones County Preschool Scholarship Program. State tax dollars are allocated to Jones County through Cedar/Jones Early Childhood Iowa to help support children and their families when they choose high quality early education for their child. Scholarships allow for access to financial assistance to help offset costs associated with early preschool education.

To apply for a Preschool Scholarship, complete the attached application and send the application and <u>a copy of your Federal Income Tax Return or Returns for all individuals</u> <u>supporting the household</u> to the Jones County Preschool Scholarship Manager.

Eligibility Criteria (check all that apply):

Your child will be 3, 4, or 5 years of age as of September 15th, 2014.

Your child lives within Jones County or the boundaries of the Anamosa, Midland, Monticello, and Olin School Districts.

Your child attends or will attend a participating high quality, licensed childcare center, licensed preschool, or registered child development home.

Your family meets income guidelines. Please note that this is gross income and includes salary/wages/stipends, unemployment benefits, SSI, FIP, Social Security, Child Support, Veteran's benefits, and direct student loans.

Your child is in Foster Care warranted through the Iowa Department of Human Services.

Recipients of Jones County Preschool Scholarships must live within the boundaries of Jones County. Recipients living outside the boundaries of Jones County, but within the boundaries of the Anamosa, Midland, Monticello, and Olin School Districts shall also be eligible for funding unless funding is available and provided by another Early Childhood Iowa area. Scholarships will only be paid to preschools within Jones County meeting program guidelines. The Cedar/Jones Early Childhood Iowa Board will review exception requests to Preschool Scholarship policies upon individual requests.

If your child is awarded a scholarship, payment will be made directly to the preschool. <u>A co-</u> payment may be required by the preschool and will be the responsibility of the parent/guardian.

Preschool attendance will be monitored by the school and reported to the Preschool Scholarship Program Manager monthly. At least 85% attendance will be required for participation in the scholarship program. If the child is sick and misses school, these days will not be included in the 85% attendance requirement if a written doctor's excuse is provided.

If attendance falls below 85%, one warning will be given to parents by program management. The second time attendance falls below 85%, the child may be terminated from the scholarship

program and not be allowed to re-enter during the current school year. Full preschool tuition will then be the responsibility of the parent/guardian.

Application for Preschool Scholarships will not be considered until a completed application and a copy of the family Federal Income Tax Return (or all supporting household income verification documentation) has been received.

*Children at or below 100% of poverty could be eligible for Head Start and need to contact the Head Start Center nearest to their home. Preschool Scholarship funds are to avoid duplication of services and funds with other preschool programming including Head Start.
