Board President Beitz stated that we approved the Resolution of Intent for the Instructional Support Program Levy (ISL) for one year, the program will be funded with instructional support state aid, instructional support property tax and income surtax and the public hearing was set for November 28, 2016. The Board members also felt that the information that Mrs. Young presented in her report (the data on the number of students with a F at this time compared to the previous 6 years is way down and the study table numbers are also down) was very interesting and goes to show that the processes that the high school staff have implemented are working.
