

BURGER KING/MCLAMORE SCHOLARSHIP

APPLICATION INFORMATION

The requirements to become a BURGER KINGSM Scholar are simple. You must apply within the application period, and fit the prerequisites below:

- Have a strong academic record with a minimum grade point average (GPA) of 2.5,
- Be passionate about serving the community, and
- Be a high school senior, BURGER KING® employee, spouse/domestic partner or child of an employee.

High school students should be graduating seniors with plans to attend a two- or four-year accredited university, college or vocational-technical school in the U.S., Canada or Puerto Rico. BK® employees can further their education by using the scholarship for non-degree courses such as accounting, computer or language courses.

If you want to go a step further, the McLamore Family Foundation created the James W. McLamore WHOPPER® Scholarship Award, granting a \$50,000 scholarship to three students each year since 2011. The four-year scholarship is intended to help the top students that apply achieve their educational and professional goals, along with serving as a tribute to Jim himself. Here are the details:

- Be a citizen of the United States or Canada,
- Have graduated from high school within the last three years or be a full-time student who is a senior at a high school or home school in the United States, Canada or Puerto Rico,
- Students who are applying as a full-time freshman to a four-year accredited, college or university that is located in the United States and is exempt from taxation under Section 501(c)(3) of the Internal Revenue Code,
- Students who have a cumulative unweighted grade point average (GPA) of at least 3.3,
- Students who have a minimum ACT Composite score of 25 or a minimum combined SAT score of 1220,
- Students who demonstrate an active leadership role in community service, athletics, and/or similar co-curricular activity (such as student government, team sports, fraternal life, etc); and,
- Students who demonstrate substantial work experience.

Scholarships range from \$1,000 to \$50,000 and the application window is open from October 15 to December 15 each year.

FAQS

Who is eligible to apply?

All high school seniors and all BURGER KING® restaurant, corporate and field employees, their spouses and children in the U.S., Canada and Puerto Rico are eligible to apply.

How will I know that my application has been received?

An email acknowledging receipt of the application is sent within 24 hours. The acknowledgement is

sent to the email address provided when registering. If an acknowledgement is not received within 24 hours, please contact Scholarship Management Services by email at burgerkingscholars@scholarshipamerica.org or call 507.931.8340.

What are the details of the award?

- BURGER KINGSM Scholars grants are awarded each year.
- The number of awards will be determined by the funds available and the number of applicants.
- Most scholarships are non-renewable awards of up to \$1,000. Awards cannot exceed educational costs.
- The scholarships can be applied to tuition, fees or books required for course load at accredited, not-for-profit two or four-year colleges/universities in the United States, Canada or Puerto Rico (Note: BURGER KING® employees may use awards to take enrichment courses at accredited institutions).
- A student may transfer from one institution to another and retain the award provided the institution and his or her enrollment continue to fulfill eligibility criteria.

Can I apply every year for a scholarship?

Awards are not renewable; however, \$1,000 Employee-Based Track (as defined in the eligibility criteria) recipients may reapply to the program each year during which they meet the eligibility criteria. These recipients are eligible to receive up to a maximum of four annual awards (up to \$4,000).

Is there a deadline for submitting applications?

Yes, the application period for the upcoming scholarship program is from October 15 through December 15. Incomplete applications will not be evaluated. Following December 15 each year, students will have access to their portal to view their submission, receive status updates and update their profile information, but no changes or additions may be made to the application. Transcripts, if required and not uploaded prior to submission, must be mailed to Scholarship Management Services by December 15.

Is a home-school student eligible to apply for the scholarship program?

Yes, as long as the student meets the criteria of the program.

Will the scholarship be taxable?

Generally, the scholarship will not be taxable as long as it is used for qualifying expenses such as tuition, books and fees. However, a recipient should consult his/her tax advisor to determine whether or not it is taxable in his/her circumstance.

How and when will I receive notification?

- All applicants will be notified via email in May of the following year.
- Recipients will also receive formal notification via U.S. mail.
- Past experience indicates that emails are sometimes not received or successfully delivered. Be sure to keep your email address current in your student profile and to check your spam folder during the notification period.

How and when are the funds issued?

- Funds will be issued via check and mailed to the recipient's mailing address on file with Scholarship Management Services in August of the awarding year.
- The check will be made payable to the institution only.

- Employees of the BURGER KING® system pursuing an enrichment program will be able to select whether they would like to receive their award check in August or November of the awarding year, or January of the following year.
- It is the recipient's responsibility to notify Scholarship Management Services should the check not arrive within 30 days of the issue date.

April/May – E-notifications are sent to recipients and non-recipients

August – Award checks are sent to recipients (including any employees pursuing an enrichment program who designate August 2019 as preferred check date). Checks are made payable to the accredited institution for the student only.

November – Award checks are sent to employee recipients pursuing an enrichment program who designate November 2019 as preferred check date. Checks are made payable to the accredited institution for the student only.

February – Award checks are sent to employee recipients pursuing an enrichment program who designate February 2020 as preferred check date. Checks are made payable to the accredited institution for the student only.
