### About AgVantage FS

### Objectives

The primary goal of the scholarship program is to encourage area students to prepare for a career in agriculture or agribusiness. This program is designed to provide college financial assistance to dependents of AgVantage FS employees or customers.

### Who is Eligible?

To apply for an AgVantage FS Scholarship, an applicant must:

- Be a dependent of an AgVantage FS employee or customer.
- Be at least a high school senior or already enrolled in a college and must have maintained a satisfactory grade point of at least 2.5 on a 4 point scale. **Please submit a copy of current transcript.**
- Scholarship recipient may receive an AgVantage FS scholarship once per year.

### Scholarship Award

AgVantage FS will offer up to ten (10) \$1,000 scholarships, and one (1) \$1,000 memorial scholarship to full-time area students with an interest in pursuing a career in agriculture or agribusiness related majors. Payments will be made to the college the student enrolls in at the beginning of the fall semester.
