The Iowa Automobile Dealers Foundation for Education will award scholarships of \$2,000 each to selected students in the spring of 2013. The Foundation is affiliated with the lowa Automobile Dealers Association, a trade organization of over 350 car and truck dealer members in lowa.

SCHOLARSHIP REQUIREMENTS:

- 1. Applications are due at IADA Headquarters by 5 p.m. on Friday, March 1, 2013. THERE ARE NO EXCEPTIONS.
- 2. Before sending your application, review your materials to be sure all documents are included. INCOMPLETE APPLICATIONS WILL NOT BE ACCEPTED. All applications and additional documents must be one sided and include the applicant's name and page number (1 of ___) in the upper right hand corner of each page. Applicants must include the following documents with their applications:
 - Signed recommendation from the President or General Manager of an IADA member dealership. Confirm the dealership is an IADA member before they sign your recommendation.
 - Cover letter written by the applicant, detailing their career goals and interest in pursuing an automotive career;
 - Transcript of high school or college grades;
 - Letter of recommendation from the applicant's high school, college teacher or counselor; and
 - A copy of the applicant's EFC (Expected Family Contribution) from the FAFSA (Free Application for Federal Student Aid) Form. FAFSA Forms are available from guidance counselors or on-line at www.fafsa.ed.gov/. The EFC is provided on the Individual Student Aid Report (ISAR). If filing on-line, print the page indicating the EFC. If filing by paper, include a copy of the EFC received in the mail.
- 3. Applicants must be committed to the pursuit of automotive or truck-related studies, such as technician training, body shop/collision repair, diesel, new vehicle sales, parts sales, accounting, or business administration. We reserve the right to rescind a scholarship award if the student fails to maintain enrollment in these types of studies prior to receiving the scholarship.
- Background checks will be conducted on all finalists.

The Foundation's selection committee will base its' decision on the student's interest and commitment to the automotive industry. An applicant's interest will be measured by their enrollment in automotive related studies (including business and accounting), being a current or prior employee of a dealership, or demonstrating a personal interest in automobiles. Preference will be given to applicants who plan to attend an lowa college or university. Scholarships may be awarded, in part, on financial need.

Generally, the Foundation will not award scholarships to:

- 1. Immediate family members (first generation) of a car or truck dealership owner
- Students who pursue studies in fields not related to the motor vehicle industry

Prior scholarship recipients who have a 2.5 GPA may re-apply. Scholarships may be applied to the factory-sponsored programs, such as Ford ASSET, GM ASEP, Chrysler CAP, or Toyota T-10.

We will select the winners in April of 2013. Alternates may also be chosen. The scholarship will be paid directly to the student's educational institution. Each recipient must submit a transcript showing courses taken and grades earned before payment will be sent.
