# **Exempt Session per Iowa Code Section**

Immediately following board meeting

- I. Bargaining sessions, strategy sessions of boards or employee organizations, mediation and the deliberative process of arbitrators in a collective bargaining process are exempt from the open meetings law. IOWA CODE § 20.17(3). Burlington Community School District v. Public Employment Relations Board. 268 N.W.2d 517, 524 (Iowa 1978).
- II. To discuss strategy in matters relating to employment conditions of employees not covered by the collective bargaining law. Iowa Code 21.9.

This is an exempt session for the Board of Education and Superintendent. There will be no action or voting taken place on any of the above items.
