Exempt Session per Iowa Code

Immediately following board meeting

- I. IOWA CODE § 20.17(3). *Burlington Community School District v. Public Employment Relations Board.* 268 N.W.2d 517, 524 (Iowa 1978).
- II. To discuss strategy in matters relating to employment conditions of employees not covered by the collective bargaining law. Iowa Code 21.9.
