2022-23 School Registration

Registration in the Monticello Community School District for 2022-23 has been scheduled for:

Tuesday, August 9 from 3-7:00pm @ Monticello High School

- E-registration will be available starting the first week of August. We are switching to a new student information system this year, so it will look slightly different. You may need to enter more information than in the past, due to the change from PowerSchool to Infinite Campus.
- You will have the option to pay online for fees (including lunch account deposits). If you choose to pay online, you are not required to come to the high school to register and may use a credit card, debit card, or e-check to pay. A convenience fee will be charged at checkout for the convenience of making your online payment. Except from August 8-12 no convenience fee will be charged!
- Schedules, padlocks, etc. can be picked up at registration or open house once fees have been paid. Chrome-books will be handed out at Open House. Please note that e-registration is still required for all students whether you pay online or come in to register.

IMPORTANT!

⇒ Before School starts in August <u>all</u> <u>Kindergarten</u>, 7th, and 12th grade <u>students</u> must have their expected immunizations per state law.



- ⇒ All Kindergarten and 9th grade students must have a current Dental screening certificate on file.
- ⇒ All Kindergarten students must be up to date on their preschool shots and have received their 4year-old boosters of Dtap, Polio, MMR, and Varicella.
- ⇒ All 7th grade and above students must show proof of having received a Tdap (Tetanus/ Acellular Pertussis) vaccination booster AND a Meningococcal vaccination on or after 10 years of age.
- ⇒ All students in grades 7-12 interested in participating in sports must have a current physical and concussion form on file.
- ⇒ All 12th grade students must show proof of receiving 2 DOSES of Meningococcal vaccine; or 1 dose if first dose was received at 16 years of age or older.

Inspection of Instructional Materials

Parents and other members of the school district community may view the instructional materials used by the students. All instructional materials, including teacher's manuals, online content or other supplementary material which will be used in connection with any survey, analysis, or evaluation as part of any federally funded programs must be available for inspection by parents. The instructional materials must be viewed on school district premises. Copies may be obtained according to board policy. It is the responsibility of the superintendent to develop administrative regulations regarding the inspection of instructional materials.

Parent/Student Rights

The Monticello Community School District maintains confidential records for all students currently or previously enrolled as is consistent with the District's responsibility for the provision of educational programs and services and the requirements of state/federal law and regulation. Copies of the District's student records policy are available upon request to the office of the superintendent or the principal of any district school.

Asbestos Notification

The Asbestos Hazard Emergency Response Act of 1986 (referred to as AHERA) was enacted by Congress to determine the extent of and develop solutions for any problems schools may have with asbestos. This notification, education and training of our employees, plans and procedures to minimize the disturbance of asbestos containing materials, and plans for regular surveillance of the asbestos containing materials are a part of our efforts to meet government regulations. Use of Video Cameras on School Buses

Students and parents are hereby notified that the content of video recordings may be used in a student disciplinary proceeding. The content of video recordings may be confidential student records and, if so, will be retained with other student records. Video recordings will only be retained if necessary for use in a student disciplinary proceeding or other matter as determined necessary by the administration. Parents may request to view video recordings of their child if the video recordings are used in a disciplinary proceeding involving their child.

Multicultural and Gender Fair Education

Annual Hearing Screening Parent Notification

Grant Wood Area Education Agency (GWAEA) screens all students in Alternative Kindergarten (AK), kindergarten, and grades 1, 2, and 5. Students in the Early Learning Program with IEP's will be screened. Students in grades 3, 4, middle, and high school, who are new to the school, that don't have a documented normal hearing test, and some students with a history of known hearing loss will also be tested. Follow up testing may occur periodically if previous hearing test results were not within normal limits. Parents/guardians not wishing their child's hearing tested should notify the health office in writing at the beginning of the year. Parents/guardians with concerns about their child's hearing should may contact their school nurse or Grant Wood Area Education Agency to schedule a hearing test at any time (319-399-6700).

Grant Wood Support Services Available

Additional support services are available to assist teachers when concerns arise with students. These services include the building staff, (special education teacher, counselor, nurse, health secretary, etc. and Grant Wood Area Education Agency support staff (psychologist, social worker, consultant, speech-language pathologist, occupational and physical therapists, work experience coordinators and others). Teachers and families may use input on an informal basis or request formal assistance in identifying strategies to address a concern, in carrying out these strategies, or in monitoring individual student progress. These services are available for all students through teacher or parent requests. Working together, we can provide the best education possible for all of our children.

Competent Private Instruction

The definition of Competent Private Instruction is any student being taught at home by parents/guardians with or without the assistance of a licensed teacher or the student is enrolled in a non accredited non-public school. It is the responsibility of the parents/guardians to submit notification forms for each child, between the ages of 6 and 16 by September 15th with the resident district. These forms are available in the Superintendent's Office at 850 E Oak St, Monticello, IA.

ANNUAL NOTICES

Open Enrollment

The Iowa Legislature removed the March 1 filing deadline for open enrollment requests. Iowa now has rolling open enrollment in place. Due to this change, language that created set calendar deadlines for responding to open enrollment requests have been removed. Parents/guardians considering the use of the open enrollment option to enroll their child/ren in a public school district in the State of Iowa other than their district of residence should file an application with the resident district and receiving district. Transportation to and from a point on a regular school bus route of the receiving district is the responsibility of the parent/guardian, unless economic eligibility requirements are met and the receiving district is next to the resident district. Parents/guardians of open enrolled students whose income falls below 160% of the federal poverty guidelines are eligible for transportation assistance. This may be in the form of actual transportation or in the form of a cash stipend. Parents should be aware that open enrollment may result in the loss of athletic eligibility. Students who open enrollment status unless the parent/guardian decides to cancel it or the agreement is terminated as a result of the parent/guardian moving, by not sending the child to the requested district or any other circumstance that results in the pupil no longer attending the receiving district. Dental Screenings

All children enrolling in Iowa's elementary or high schools are required to have a dental screening as of July 1, 2008. The purpose of the dental screening is to improve the oral health of Iowa's children. Dental screenings help with early detection and treatment of dental diseases. This requirement applies only to those students entering kindergarten and the ninth grade. The dental screening is to be performed by a dentist or licensed dental hygienist. The dental screening requirements are:

- Kindergarteners to have a screening sometime between age 3 years to four months after their enrollment into Kindergarten
- 9th graders to have a screening that is valid for up to one year prior to their enrollment into 9th grade and up to four months
 after their enrollment

Iowa's State Dental Screening forms need to have been signed by a dentist or dental hygienist and the form turned into the child's respective school by December 15th of the enrollment into Kindergarten or 9th grade year. If the forms are not turned in, the Monticello School District will have a licensed dental hygienist from the I-SMILE program come in and do FREE dental screenings for that child. If the parent/guardian does not want their child screened, a letter expressing this must be turned into the child's school administrator by January 1st of that school year. The free dental screenings will be conducted during the second semester of the Kindergarten/9th grade enrolling school year.
