Hello everyone,

As we move into March we have a lot going on in the Monticello Community School District. Up to this point we have had five snow days; however, we are working on completing the second of two virtual make-up days for our district. When the second day is completed, we will only have three make-up snow days left. Also, since we are a school district that runs on hours completed and not school days attended, some of those days may be waived at the discretion of the school board. The school board will decide that in April when the majority of the weather has passed for the school year. Until then, keep your fingers crossed for good weather.

When we return from Spring Break we will be down to the final two months of the school year. We will have the state standardized tests (ISASP Tests) at the beginning of April. We are hoping to get the results of these tests back before by June and mail them home. Please take some time to discuss the importance of "doing your best" with your child before they take these tests in April. Especially with the older students, sometimes they do not understand the importance of these tests because they do not directly impact their grades. The ISASP tests do give us information on the academic progress of each student and we use this information to determine classroom placements, effective resources, and the selection of the best instructional practices for our students. These results are also good for parents because they show each student's proficiency, in each area tested, in an easy to understand format.

Finally, our School Facility Committee has met for the first time to discuss and consider options for an elementary school project. Historically our community has wanted a single campus plan for our school district and we took a step in that direction with the new middle school. Our School Facility Committee was able to tour part of the new middle school as well as Shannon and Carpenter Elementary schools this week. Stay tuned and I will keep you updated on the continued progress of this project.

FAFSA Info for SENIORS

If you have tried to complete the FAFA form, you may have experienced some problems with this "updated" version of the Free Application for Federal Student Aid. Originally released during the month of October, this year's form was finalized at the end of December and has encountered some delays. Federal Student Aid has announced that they need to update their Student Aid Index (SAI) tables to adjust for inflation. The SAI helps determine eligibility for the Pell Grant. The adjustment should help more families be eligible for Pell Grant Funding but this update has created a delay in the processing of the FAFSA forms. Colleges and universities will now receive your student's FAFSA information the first half of March (no specific date announced). Many colleges have extended their financial aid priority deadlinecheck college financial aid websites for this information.

Due to this SAI update, students will not receive verification that their FAFSA has been processed until the beginning of March. If you need to correct an error on your form, you will not be able to make changes until after your FAFSA has been processed. With these delays, it is likely that you will not receive financial aid award letters from the institutions you sent the FAFSA information to until April or later. Some colleges/universities have pushed back their admissions deposit deadlines to accommodate these delays. Please check with your college/university to check out this deadline.

We feel the changes that were made to the FAFSA will eventually be beneficial to families but understand that the delays in processing have been frustrating. If you have questions about filing your FAFSA, reach out to ICAN at www.icansucceed.org.

Homeless Youth

The Monticello School District Homeless Youth Coordinator is Denny Folken, Elementary Principal. Homeless Coordinator Duties:

- Locate and identify homeless children or youth within the district, whether or not they are enrolled in school 281—IAC 33.3(1)
- Provide evidence the definition of "homeless" is communicated in staff, parent, and student documents (e.g., newsletters and hand-books) (HCY4)
- Post information, at community shelters and other locations in the district where services or assistance is provided to the homeless, regarding the educational rights of homeless children and youth and encouraging homeless children and youth to enroll in the public school (HCY2). 281—IAC 33.3(2)

Definition of Homeless Youth:

If a student is living in any of the following situations, it is considered to be a homeless situation.

In a shelter, motel, vehicle, or campground; on the street; in an abandoned building, trailer, or other inadequate accommodations, or doubled up with friends or relatives because you cannot find or afford housing,

McKinney-Vento Homeless Education Assistance Act (as it appears in Monticello Schools parent and student handbooks)

Homeless children have the right to:

- Go to school, no matter where you live or how long you have lived there.
- Continue in the school they attended before you became homeless or the school they last attended, if that is your choice and is feasible.
- Receive transportation to the school they attended before your family became homeless or the school they last attended if you or a guardian requests such transportation.
- Attend a school and participate in school programs with children who are not homeless.
- Enroll in school without giving a permanent address.
- Enroll and attend classes while the school arranges for the transfer of school and immunization records or any other documents required for enrollment.
- Enroll and attend classes in the school of your choice even while the school and you seek to resolve a dispute over enrolling your children.
- Receive the same special programs and services, if needed, as provided to all other children served in these programs.
- Receive transportation to school and to school programs. When you move, you should do the following:
 Contact the school district's local liaison for homeless education (Denny Folken, Shannon and Carpenter School Elementary Principal 319-465-3000) for help in enrolling your child in a new school or arranging for your child to continue in his or her former school.
 (Or someone at a shelter, social services office, or the school can direct you to the person you need to contact.) Contact the school and provide any information you think will assist the teachers in helping your child adjust to new circumstances. Ask the local liaison for homeless education, the shelter provider, or a social worker for assistance with clothing and supplies, if needed.

KINDERGARTEN REGISTRATION

Kindergarten Registration is open for students entering Kindergarten in the Fall of 2024. Parents are asked to use the electronic registration form to create their student in Infinite Campus: https://monticelloia.infinitecampus.org/campus/OLRLogin/monticello?configGroupID=4. Students must turn 5 years of age on or before September 15, 2024 to attend Kindergarten. Completed immunizations, physical, and a dental exam are required by law for all students entering Kindergarten. Some of the series of vaccines take six (6) months to complete. Start now to make sure all needed immunizations are completed before your child starts school in the Fall 2024!

There are some forms that you will need to download, fill out, and turn into Shannon Elementary by the time your child starts school. Forms include: IDPH Dental Screen, IDPH Vision Screen, Iowan Migrant Parents Form (*everyone must fill out*), Home Language Survey, and a physical form with LEAD screening date. COMMUNITY CONNECTION

Guiding Middle Schoolers to Make Good Choices

Values can provide a useful compass when kids are making social choices. Middle schoolers want to be kind, but they're egocentric and often can rationalize self-serving or mean behavior. To prove this to a seventh-grade class—and to help them make kinder choices—I presented a scenario. "Imagine that one of your classmates invites you to a sleepover. This is someone who is quirky, awkward, and much less popular than you, but you like them and don't mind hanging out with them, so you agree to the sleepover. You know it's a big deal because they keep asking you questions such as, 'What movie do you want to watch when you come? What snacks do you like?'"



I then complicated matters. "A week before the sleepover," I told them, "Your best friend invites you to a sleepover birthday party with your five closest friends on the same night. You really don't want to miss her party, but you also don't want to disappoint your classmate by backing out. Would you keep the original plans or bail?" I told them it was OK to consider their personal preferences, but I wanted them to factor kindness into the equation. (Because seventh graders are good at finding loopholes, I added a couple of disclaimers. They couldn't reschedule the first sleepover, and they couldn't invite their less-popular friend to their best friend's birthday party.)

I asked the students to break into groups of three and discuss how they would handle the situation. Afterward, I asked whether anyone decided to bail on the original plans. Nearly every hand shot up. One student said she not only wanted to go to her best friend's sleepover party, but she also felt that was the kinder choice. When I asked her to elaborate, she said, "You should always put the needs of your best friend before the needs of a sort-of friend." Many heads bobbed in agreement.

Afterward, I handed out a list of about eighty values—including achievement, health, contribution, excitement, creativity, purpose, pleasure, friendship, generosity, kindness, risk, fun, and compassion. I asked them each to identify their ten core values, the ones that best captured how they wanted to conduct themselves and be perceived. When they had created their lists, I asked them to revisit the sleepover scenario. This time, I told them I wanted them to forget their personal preferences and make the choice that was most closely aligned with the ten values they had picked. This time, only one person said they'd bail on the original plans. "Now, imagine it's six weeks or six months after the sleepover," I said. "Which decision do you think you'll be happier with then?" Most predicted that they would feel better about the values-driven decision down the road. As I told my students, I think the exercise eliminates much of the emotional interference—such as FOMO, jealousy, or insecurity—that can cloud their judgment.
